- g) INTERNATIONAL SCHOOL OF THEOLOGY-ASIA (ISOT-ASIA), Quezon City;
- h) KOINONIA THEOLOGICAL SEMINARY (KTS), Davao City; and
- i) PRESBYTERIAN THEOLOGICAL SEMINARY (PTS), Cavite

This Government Recognition (GR) is valid effective Academic Year (AY) 2013-2014 and shall be subject to revocation if the herein grantee fails to operate in accordance with the laws of the Republic of the Philippines and/or fails to maintain the prescribed standards of instruction and/or fails to comply with the rules and regulations pertaining to the organization, administration and supervision of private/public Higher Education Institutions (HEIs) in the Philippines.
