Subject: Accreditation of the Namal University, Mianwali

Reference to the subject cited above. I am directed to state that after physical inspection of the Namal University, Mianwali carried out by HEC Accreditation/Inspection Committee to ascertain the available academic facilities, based on provision of documents and recommendations of the said Committee, the Competent Authority is pleased to grant NoC to the Namal University, Mianwali till December 31, 2024 in following degree programs at undergraduate level only:

- i. B.S. Electrical Engineering
- ii. B.S. Computer Science
- iii. B.S. Business Administration
- iv. B.S. Mathematics
- 2. The NOC is subject to following conditions:
 - i. The NOC is granted for specific location only i.e. 30 km Talagang Road, Mianwali and shall not operate from any other location/premises. New/additional degree program(s) except mentioned above shall only be offered after seeking approval of University's statutory bodies and after fulfillment of prescribed criteria.
 - ii. University ensure that students (enrolled in various degree programs) do not suffer on account of inadequate faculty, the Namal University, Mianwali shall maintain: one Professor, one Associate Professor, two Assistant Professors and two Lecturers in each department.
 - iii. Namal University, Mianwali must ensure appropriate Quality Assurance mechanism, academic mentoring and examination/assessment mechanism for smooth/effective functioning of the University.
 - iv. The Computer Labs should have facility of scanners available and the computers should be upgraded as well.
 - v. Namal University, Mianwali shall seek accreditation from the accreditation Councils for its relevant degree programs.
 - vi. University shall ensure proper record maintenance i.e. Students' Admission/Registration Forms in original, Award Lists (semester wise results), Tabulation Register (for scrutiny of award lists), and Gazette Notifications (of graduates) in hard as well as in soft form through automation to determine the authenticity of graduates and to avoid any malpractice in the students record.
 - vii. University shall ensure provision of appropriate facilities for the differently abled students.
 - viii. No MS/M.Phil./PhD programs shall be initiated without the prior approval from Ouality Assurance Division of HEC.
- 3. The University is advised to comply with directions of HEC and shall submit compliance report by **October**, **2024** before expiry of this NOC. The Inspection/Accreditation Committee will again visit Namal University, Mianwali to evaluate the programs as per above recommendations.

- 4. Moreover, as per the request of the University vide letter no. NUM/REG/HEC/2023-26 dated June 16, 2023 and the supplementary documents (including the minutes of the BoG and consent of the students) provided by the University, Namal University may confer degree to the already enrolled 404 students of Namal Institute (as per the list provided by the University), under the seal and signature of the Namal University, Mianwali, provided that concurrence of the relevant accreditation councils must be sought.
- 5. HEC reserves the right to withdraw this NOC in case it is found that the University is unable to satisfactorily demonstrate its ability and commitment to achieve and maintain national academic standards.
- 6. This issues with the approval of the competent authority.
